Oakcliff Sailing Center is proud to offer thousands of dollars each year in tuition assistance. Scholarships are available to young sailors who show potential to be high-performing Acorns who would be unable to attend without financial aid.

Oakcliff is the only organization offering merit-based opportunities for Saplings working toward being the next generation of top American racers. Scholarships are made available by generous individual donations from Oakcliff supporters, parents and alumni in recognition of Oakcliff's contribution to the sport of sailing.

Typical tuition assistance ranges from \$500-\$3000. Full scholarships are unusual. Please do not apply for more money than you need. Tuition aid for the Sapling Program is merit-based while tuition aid for the Acorn programs factor in both merit and financial need.

While there is no deadline for financial aid applications, scholarships are awarded on a first-come, first-serve basis, so you are encouraged to apply as early as possible. Financial aid review occurs after admissions decisions are made, in the order the applications for aid were received. We may request additional information before a decision is made.
